

## SCMA ELC Audit 2021 Parent / Carers Survey

A snapshot survey of 276 parents in 30 local authority areas from 26 August - 24 September 2021, conducted in parallel to a similar snapshot survey of childminders, to complement the SCMA Early Learning and Childcare Audit 2021.



**MAIN FINDINGS** 

 49.4% of parents who are accessing funded ELC through a childminder and 67.9% of parents <u>not</u> accessing funded ELC through a childminder reported that childminding was not promoted equitably alongside local authority nursery provision as an option to them for receiving their funded ELC entitlement.

**49%** of parents using a childminder for ELC said it was <u>not</u> promoted equitably alongside other options.

 responses from parents who are accessing funded hours through a childminder, confirm that very few childminders are involved in delivering funded hours to the Scottish Government's priority group of eligible two-year-olds (low-income families); that the vast majority of childminders involved in delivering funded hours to parents are doing so at a lower level and as part of a blended placement, (also involving a nursery), for three- and four year-olds (63.2%).

**64%** of parents accessing funded ELC with a childminder found the process easy.

• 64.4% of parents who are accessing funded ELC through a childminder found it very easy/easy to do so, as many of these parents had already been accessing childcare from their childminder, and the childminder supported parents through the application process.

However, it is of concern that almost 1 in 4 parents accessing funded ELC through their childminder, reported finding it very difficult/difficult to access through their local authority.

• parents reported significant restrictions within local authority offers as to when funded ELC could be accessed:



 $\rightarrow$  28.2% of parents using a childminder and 55.6% of parents not accessing funded ELC through a childminder reported that offers received from local authorities required funded ELC to be accessed on fixed days of the week;

 $\rightarrow$  40% of parents using a childminder and 77.8% of parents not accessing funded ELC through a childminder reported that offers received from local authorities required funded ELC to be taken at fixed times;

 $\rightarrow$  20.5% of parents using a childminder and 33.3% of parents not accessing funded ELC through a childminder reported that offers received from local authorities included a requirement to take some, or all, of their funded ELC with a local authority nursery;

**20%** of parents using a childminder were required to take some, or all, of their funded ELC with a local authority nursery.

**MAIN FINDINGS** 

- 56.3% of parents who are accessing funded ELC through a childminder and 73.2% of parents not accessing their funded ELC through a childminder believe local authority offers for funded ELC need to be much more flexible/more flexible. Some concern was expressed about nurseries allocating funded ELC in fixed 10-hour days which resulted in wasted hours, and a reduced ELC entitlement for families, where this did not match the parents' need (i.e. 9.00am 3.00pm). Conversely, some working parents found fixed 9.00am-3.00pm offers too restrictive;
- more encouragingly, 59.1% of parents accessing funded ELC through a childminder and 74% of parents not accessing their funded ELC through a childminder reported receiving their first choice of preferred provider. However, this needs to be qualified with concern about the lack of choice and options available locally. 60.5% of parents using a

**50%** of parents not accessing funded ELC with a childminder only received a single option from their local authority.

childminder and 50.9% of parents not accessing their funded ELC through a childminder only received a single option for accessing their funded ELC within the offer from their local authority. As such, preferences could clearly differ if parents were presented with more options and the ability to make an informed choice. Encouraging satisfaction ratings were

also reported by parents (higher in those accessing funded ELC through a childminder than in those not accessing their entitlement through a childminder), qualified by parental recognition that this is a free offering.

> **73%** of parents not accessing funded ELC with a childminder believe local authority offers need to be much more flexible.
