

# Scottish Childminding Association Membership Survey Results 2019

The following results are from our recent Membership Survey; distributed by email to 4321 SCMA members on Monday 21 January 2019. The survey received 736 responses, which is a response rate of 17%. In 2018 we collected 564 responses; therefore the 2019 survey has attracted more respondents and membership participation, with a significant increase of 30%.

Our annual Membership Survey provides SCMA with an overview of membership services, products, how we are rated by our members and the areas we can improve on. Feedback and results are divided into six sections: Membership, Learn with SCMA, SCMA Online, *Childminding* Magazine, Early Learning and Childcare and the Prize Draw.

- With 2020 approaching I am very confused about which qualifications I need. Although I have a degree, it is not in childcare. I am open to obtaining a relevant childcare qualification but I'm keen for this to be as straightforward as possible, given the demands of time and cost.
- I would like more information to help me choose suitable courses.
- Time is a huge factor, when working from home, there is a huge amount of cleaning and clearing up to do before normal family time and home life takes over which doesn't leave much time for paperwork, training and forum meetings.
- Courses led by industry professionals have been brilliant and exceptionally inspiring.

They didn't stand by the curriculum of excellence, which could have been adjusted to suit (it did take 2yrs to complete). We have no area support and receive more updates from Aberdeenshire Council than SCMA. Training is few and far between. My feedback is in my previous comments. I think childminders who have been childminding for years and done the courses SCMA recommended should get some credit towards each of open badges. I want the SCMA to level the playing field and ask the Scottish Government to fund us with subsidies to try to ensure childminding actually pays. As it stands, I would be better off looking after a dog or cleaning and I think that says it all.

I would love to do the open badges but would like help at least with the first one

I'm not great with doing anything on line and haven't accessed the open badge as no idea how to use it. I am at an age that by the time I completed Complete Childminding Learning Pathway, I would be retiring. I currently have no access to funding for training and at £200 unit it would take years.

Have accessed so many courses on my childminding journey, and I'm due to retire in the near future, so don't feel it necessary to do many more.

I am a retired health visitor with a 1st class honours degree in child development. and post graduate certificate in child protection

Have accessed play training first aid and compulsory child protection so struggle to know where to go next. Would be good to achieve Open Badges without having to write about a course I have just done. Being dyslexic having to wrote 200 words can be quite intimidating. Also having spent time doing a course in our own time them having to spend more time writing 200 words I find it quite frustrating.

Yes I would have liked to have achieved the Work based Award and actually did not have that much more to do, but the way you blocked them together was not flexible for instance even though I may have completed all but one course and also completed the open badge it would cost me £200 to do that one missing course to complete a unit. When I can just buy the course separately from yourself at £25 and then go on and do the open badge. If I didn't already have my SVQ3 I would have been very upset regarding this issue. Some of the courses North Ayrshire provide are far to travel to. Something closer to Largs or Saltcoats would be better for me to get to.

The expense is often the main barrier to taking part in courses, even with an ITA account

Please fight our case with local authorities, each one is telling/issuing different criteria and nobody is telling us!

I have used the on line training and attended training events in our area. As I am retiring at the end of June will not be using any future training opportunities.

Will possibly retire from childminding in near future, so will not be attending much training. Already hold SVQ III.

I am fully qualified with a PDA in level 8 child care and have been told this is a higher qualification than the course that's being offered.

As I said above, better quality training would be amazing, especially since we want to be at the same level and quality of nurseries. I'm sure they receive much better training than what's on offer to us. I find at the annual conference the best things about it are the outside agencies. I think we could do so much better. I feel I have lots of experience working as a childminder for over 21 years. I have obtained my SVQ2 & SVQ3 in Early years childminding

I prefer face to face learning events as you get to hear others thoughts rather than just churning through internet pages ticking boxes.

I have been a member of SCMA now for 9 years and I'm very disappointed in the lack of help us childminders receive if any at all. In the last meeting we did have being told if we arrange enough people to make up 12 SCMA will then put on the course/s needed. However being told a first aid course will cost

£140.00 per person is not acceptable. I am looking at chanceing in time for my best renewal. Very disappointed in SCMA!!!!

Thank you for all your hard work all who work within the SCMA

With 2020 approaching I am very confused about which qualifications I should be considering. Although I have a degree, it is not in childcare. I am open to obtaining a relevant childcare qualification but am keen for this to be as straightforward as possible given the demands of time and cost. I struggle to find the time to consider all the qualification options never mind actually choose one path and complete it.

Some of the courses are more expensive than others online so financially I go with the cheaper but would prefer SCMA courses

Keep up the good work!

I'm currently doing my SVQ so haven't done much other training lately to gain badges.

I have just recently completed my SVQ 3 with 74 points only for now to hear that I need 75 points to allow me to provide funded hrs I would've liked to have this type of knowledge also I am unaware if WDC recognise the new SCMA qualification

I realise I have had little to do with the SCMA (see above) but I am now considering using your resources for my CPD etc. Watch this space...

Would really like a local first aid training course asap. More info on care plans. Expensive

I would definitely like more information to help me choose suitable courses.

I am overall happy with SCMA but have marked you down as I am disappointed despite phoning twice a few months ago I am still waiting on a call back from training team re a test for my food hygiene course Maybe more training on improving children's wellbeing/ building resilience and positive attitudes.

Plan on starting the childminding learning pathway in 2019

due to the distance of most training we don't bother with most SCMA training. It's also the cost. When we try to get SCMA up to highlands it's expensive but most times we can get others to cover the course more local for very little

Not sure about the cost of it all.

I would be interested in accessing on demand training, but don't know enough about how it works, or what my fellow, local childminders would be interested in

I would like to say I cannot praise Greg the gentleman Who heads the training department. He is a fantastic ambassador for the SCMA.

I have been at college studying and have now got a PDA in childhood practice and feel I need a break - I did e learning courses by SCMA but not sure if that includes the open badges?

I feel the complete Learning Pathway would not suit me if I am to provide funded care, it would make more sense to start working towards gaining the SVQ3 required by the councils to become a partner provider. I would love to do the open badges but would appreciate help at least with the first one.

It is very expensive for me as I have to pay for it.

I think you should go back to allowing you to book e-learning online and get emailed the access and be able to search what training is available in your area.

The complete childminding learning pathway is not available at the moment as it has been suspended as I had applied to do it and have not heard anything back!

Great service will continue to use this over my tears of childminding. Everything I need is online or just a phone call away.

Miss the old training courses, the new ones have been a bit of a non-start for my assistants

Yes. It is not made clear who such open learning badges are recognised by. Currently we are being asked for an SVQ3 in order to add to the tender. Where does the open learning pathway sit?

No. I have my svq3 and attended most courses. Haven't bothered to do essays about previous courses for an open badge

I would find templates of new paperwork requirements very useful so that I know I am not missing any important bits.

Lack of training in this area. Haven't had any SCMA training for a long time. Find Cala Highland far better. I think most in this area will leave SCMA. Any SCMA training here has always been well attended so if courses offered there would be a demand.

I'm finding it difficult filling out care commission application. And any time i call for help im left on hold or rings out. Help me!

Yes I would like to highlight the biggest concern that should be brought to attention, all Care inspectorates work in different ways and have different opinions to inspections we can all do amazing work developments and meeting the standards working with our mindees, and we all work hard to achieve this but depending on the CI inspector and how that inspector relates to the childminder they can grade you what they wish, please

can SCMA approach this matter surely if a childminder does everything and more that's required then they should be graded by the outcomes they have evidenced and not that the CI just couldn't be bothered to do the extra leg work this is becoming more of a concern to us all and very deflating to the point that Childminders are saying what is the point please can this be raised with the Care Inspectorate and suggest that they have a criteria for all CM to aim for and be rightfully credited for it, I have helped so many people out with paperwork, observations linking SHANARRI, building the ambition etc. helped the do GDPR documentations and yes they recurved 6's and yet my CI has graded me with 5's give her due she did not that she had never seen so much detail in observations even in a nursery and yet I was still graded 5's on the 24th December, this has to be approached to the CI as it's becoming a massive issue to CM.

Not sure you can help but I offer funded spaces at the moment. After 2020 I will need svq3 (I got svq2in 2000) but I can't afford to take time out to attend college or pay huge amount for the SVQ

Scma complete learning pathway is very expensive to complete and I'm not sure if it will need be enough to be able to count towards funded hours come 2020

Your course is not a SVQ level 3 so no use to offer funded care plus council pay towards SVQ not interested in open badges or the work-based award. I completed my SVQ this year. Slow to pass info on to members i.e. GDPR

I believe we could have been given much more info on GDPR. It would have been good to receive paperwork prior to its enforcement.

Expensive to access, given that I have already completed all the relevant training that is encompassed within the Learning Pathway Award Qualification.

Given my age and hope to retire I have no interest in gaining access to this

I would need to look into more.

Time is a huge factor, when working from home, there is a huge amount of cleaning and clearing up to do before normal family time and home life takes over which doesn't leave much time for paperwork, training and forum meetings.

It frustrates me when I email an enquiry to be told to phone. Email is more convenient for me and surely most enquiries can be responded this way. Apart from my insurance I don't feel I get much from SCMA. Bring costs down and give a variety of courses, it's the same ones over and over

Not a lot of courses near us, always more than an hour away in the winter time in the dark, icy roads, after working all day
