

Memorandum and Articles Resolution 2021

The Office of the Scottish Charity Regulator (OSCR) have sent out correspondence recently advising charities to check their Memorandum and Articles to ensure that meetings can be held online. Please note that OSCR understand that due to the pandemic this is a challenging time for charities, they are not going to penalise any charity who held an online AGM last year however we do need to review and update our current constitution.

Please see OSCR information below:

Throughout the pandemic, one of the ongoing challenges for charity trustees has been how they can govern their charities well despite not being able to get together face-to-face around the board table.

OSCR has been actively encouraging charities to look at the best possible way of having good meetings. What we have seen during the COVID-19 restrictions is that many organisations have embraced new ways of doing things, with many trustees getting more and more comfortable with using the online space to have meetings and make decisions. However, one of the difficulties has been that the governing documents of some charities do not permit an online approach.

SCIO legislation

On 30 September 2020, the <u>Corporate Insolvency and Governance Act 2020 (Meetings of Scottish Charitable</u> <u>Incorporated Organisations) (Coronavirus) (No. 2) Regulations 2020 (legislation.gov.uk)</u> made legal provision for SCIOs to be able to hold member's meetings using 'virtual' methods whether or not governing documents permit this. These provisions have now been extended until the 30 March 2021. This is likely to be the last extension to these provisions, and so it is very important to make sure that your charity is 'future proofed' in terms of being able to conduct meetings virtually by allowing them in your governing document.

Background

The Memorandum and Articles of SCMA have been in place since 2006 with a few minor changes in 2013 and 2016. The members of the existing Scottish Executive Board reviewed these suggestions at their meeting in March 2021 and are now proposing the changes listed above.

The two main changes are:

I To allow Scottish Childminding Association general meetings to be held online.

The main reason for this change is to ensure that we are able to continue to meet our governance responsibilities to allow meetings to be held online. Currently our Memorandum and Articles only allow for in person meetings which given that so much is done online and in particular due to the current pandemic this seems restrictive.

2 To remove the reference to members signing a written consent when they join.

As all of our members join by telephone/online we are proposing to remove the reference to them physically signing a written consent when they join. We will modernise how the member consents to being part of Scottish Childminding Association and update the process to ensure its fit for the future.
