Personal Plans (sometimes referred to as Care Plans or a Child's Plan) set out the essential information that childcare providers in Scotland are required to hold for each child in their service.

Please refer to the guidance contained within the Personal Plan Organiser when completing the relevant forms. Personal Plans should be updated at least every six months.

SCMA Personal Plan Organiser is an all-in-one tool to help you organise your Personal Plans, record information and meet the needs of your childminding service. Developed alongside the Care Inspectorate, our Personal Plan Organiser is a binder that contains forms, records and templates to ensure you comply with the law and the requirements of your registration.

babysit children in their own family home. Procedures apply

- ✓ Loss or damage to third party property limit of £10,000,000

- ✓ Contingent Motor Liability
remember this does not replace your standard car insurance
- ✓ Outings, crèches and other meetings cover for all childminding events, outings and activities.

Please note that there is a third party property damage excess of £50.00.

Got a childminding assistant?

Employer Liability Insurance is essential for services that are registered with a childminding assistant(s), including unpaid and paid employees.

SCMA provides free Employers Liability Insurance (ELI) to members who are Public Liability Insurance policyholders with us. To request ELI, please call **01786 445377** and our friendly staff will add it to your policy at no extra charge.
